ORDER

Whereas Jhang CGHS LTD., Plot No. 40, Sector-13, Rohini, New Delhi-110085 is registered vide Registration No. 505/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Vide letter dated 06/10/2025, the Secretary of the society requested this office to appoint a Returning Officer to conduct the election of the M.C of the society u/s 35(1) at the earliest. The last election of the society was held on 20/11/2022.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh. M.K. Negi, Retd. Grade-I as Returning Officer in Jhang CGHS LTD., Plot No. 40, Sector-13, Rohini, New Delhi-110085 under section 35 (1) of DCS Act, 2003 with remuneration of Rs. 10,000/- (Ten Thousand Only) consolidated from the society's fund. The Returning Officer may hold election within a period of 90 days.

The other expenses of the election will be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the guide lines for the elections available in Rule-53 and of Schedule-II of DCS Rules, 2007.

Further, if elections are not held by 19.11.2025, the Returning Officer will perform the duties of Administrator-cum-Returning Officer under section 35(5) of DCS Act, 2003 from 20.11.2025 onwards. The Administrator-cum-RO will be paid remuneration 10,000/- (Rupees Ten Thousands Only) & conveyance per month from the society fund.
