- IV. The Committee may hold its meetings as and when required at the discretion of Chairperson & Presiding Officer of the Committee, including Seminars & completion of annual reports.
- V. The Competent Authority can terminate the appointment at any time without assigning any reason and giving any prior notice.
- VI. Your appointment is subject to your acceptance, which may be given within a week of receipt of appointment letter.
