ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, *The ESIC Friends Co-operative Group Housing Society Ltd.* (Regd. No. 576) Plot No. 34, Sector-13, Rohini, Delhi-110085 with this Department under the provisions of the DCS Act, 2003, the Rules framed there under, and the Bye-laws of the Society.

And whereas, vide the letter dated 14.02.2026 received from Ms. Rekha Rani Dharmesh, Ex. President of the *The ESIC Friends CGHS Ltd.*, wherein it has been informed that out of the total nine members of the Managing Committee, eight members including the President had tendered resignation from Management Committee. The society has requested to appoint a Returning Officer to conduct election of the Managing committee.

And whereas, the Registrar, Cooperative Societies has considered the matter and approved for the appointment of Sh. Suraj Bhan, IES (Retired), as Administrator-cum-Returning Officer under Section 35(5) of DCS Act, 2003 in *ESIC Friends CGHS Ltd.* with immediate effect. The Administrator so appointed shall conduct the election of the Managing Committee within a stipulated period of ninety (90) days from the date of his appointment. He shall be paid remuneration of ₹10,000/- (Rupees Ten Thousand Only) per month plus applicable Travelling Allowance and other obligatory expenses to be borne from the funds of the Society. Further he will also submit monthly progress report about the state of affairs of the society by 10th of every month.

Further, the erstwhile Managing Committee, of *The ESIC Friends CGHS Ltd.* is hereby directed to hand over the charge of all relevant records and documents of the Society to Sh. Suraj Bhan, IES (Retired) immediately, under intimation to this office.
