CIRCULAR

Subject: Filling up of posts of Vehicle Driver on promotion quota in the Pay Band-I Rs. 5200/- to 20200/- with grade pay of Rs. 2400/-.

Applications are invited in pursuance of the approval accorded in the 176th Board Meeting of Delhi Jal Board, held on 21.01.2026, as circulated vide Minutes of Meeting dated 23.01.2026. As per Resolution No. 1537, Item No. Admn.-729, approval has been granted for a one-time relaxation in the prescribed educational qualification clause in favour of **Beldar-cum-Driver who were initially engaged as Vehicle Drivers on a contractual basis during 1997-98 under the then applicable Recruitment Rules (RRs)**, which prescribed Middle Pass as the minimum qualification. Subsequently, they were regularized as Beldars vide DJB Resolution No. 1710 dated 09.09.2008. At present, these officials are performing duties as Beldar-cum-Driver on departmental vehicles and are being paid a fixed allowance for such duties.

Accordingly, applications are invited for filling up the existing vacant posts of Vehicle Driver in Pay Band-I (Rs. 5200-20200) with Grade Pay of Rs. 2400/- plus usual allowances as admissible under the Rules, in terms of the amended Recruitment Rules.

The applications should be submitted through the DDO concerned. The DDO concerned will forward the application after duly verification of the service particulars of respective applicant to the office of DD(G)-I as mentioned at the of circular.

Application in absence of the self attested copies of the certificates/Driving Licence or incomplete information or without the signatures of the employee/DDO as stated above are liable to be rejected.

Application should be routed through the DDO concerned and no direct application will be entertained in any case. The application should reach this office on or before 15.04.2026 upto 6:00PM. No application will be entertained after due date, even if it is diarised in parent office prior to 15.04.2026.

All the DDOs are requested to please check all the particulars mentioned in the applications furnished by the employees from their service record especially regarding SC/ST status of the applicant and before forwarding the applications should certify that the particulars of the concerned employees from his PF&SB have been checked & and found correct.
