**ORDER**

Whereas, the Kangra Adarsh CGHS Ltd., Plot No.377-A, Kangra Niketan, Vikaspuri, Delhi-110018, registered vide Registration No. 33/GH with this department under the provision of DCS Act, 2003 and Rules 2007 framed there under and registered Bye-Laws of the society.

And Whereas, Sh. Manmeet Singh Walia (Joint Secretary, Law) was appointed as Inspection Officer u/s 61 of DCS Act, 2003 vide this office order dated 15.05.2025 to conduct the inspection in Kangra Adarsh CGHS Ltd., on the following points:-

- i. Registration of trust namely 'Shiv Shakti Mandir Sewa Trust' for which the erstwhile Management Committee issued NOC on behalf of the society for registration of the said trust which is violation of Rule 110(6) of the DCS Rules, 2007.
- ii. Typed minutes of meeting has been pasted on the last page of the proceeding register after closure of the register and it alleged in the complaint that purported minute of meeting dated 10.08.2020 pasted after duly recorded handwritten minutes of meeting dated 03.09.2020 which prima facie amount to falsifying/tampering of the records of the Cooperative Society.

Whereas, Inspection officer submitted the Inspection report in this office on date 19.06.2025 with the observation "that the typed minutes of the meeting dated 10.08.2020 were pasted after the handwritten minutes of meeting dated 03.09.2020 which indicates the falsification Minutes register and contravention of the provisions of subrule (4) of rule 60 of the DCS Rules, 2007 read with Byelaw 23 (a) (iv) of the society. Moreover, upon careful perusal, the signatures of the erstwhile Secretary of the MC on the said NOC also seem to be inconsistent with his signatures at other places. However, this discrepancy warrants a scientific handwriting analysis to verify the authenticity of the signatures and determine whether any forgery has occurred".

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. Gulshan Ahuja (BDO, Najafgarh) as Inquiry Officer u/s 62 of DCS Act, 2003 to conduct detailed investigation on the violations observed by Inspecting Officer in respect of above mentioned two points of the Kangra Adarsh CGHS Ltd., within 90 days.

He will be paid Rs.15000/- (Rs. Fifteen Thousand Only) as honorarium paid from the society fund for this purpose.

This issues with the prior approval of Competent Authority.
