Whereas, the Milan Vihar CGHS Ltd., Plot No. 72, I.P. Extension, Patparganj, New Delhi-110092 is registered vide Registration No. 455/GH with this department under the provisions of the DCS Act, 2003 and 2007 Rules framed thereunder.

Whereas, this office vide order dated 13.11.2025 appointed Sh. Sagar Khanna, Section Officer, as Returning Officer under Section 35(1) of the DCS Act, 2003 to conduct the election of the Managing Committee of the said society.

He is directed to conduct the election of the Managing Committee of the society as per the election agenda dated 04/12/2025 already issued, and complete the election process within the prescribed time. He shall submit his detailed report to the undersigned immediately after completion of the election.

He shall be paid Rs. 10,000/- (Rupees Ten Thousand Only) as one-time honorarium plus conveyance charges from the funds of the society for this purpose.
