ORDER

Whereas, Milan Vihar CGHS Ltd., Plot No. 72, I.P. Extension, Patparganj, Delhi-110092 is registered vide Registration No. 455/GH under the provisions of the Delhi Co-operative Societies Act, 2003 and Rules, 2007 framed thereunder and the registered Bye-laws of the Society.

And whereas, an inspection/inquiry u/s 61 of the DCS Act, 2003 was earlier conducted by Sh. Ajay Arora, for which the Society deposited an inquiry fee of ₹15,000/- vide Cheque No. 231516 dated 05.06.2024, in respect of alleged irregularities relating to road relaying work in the Society.

And whereas, on the basis of the said inspection report, further inquiry u/s 62 of the DCS Act, 2003 was ordered by the Competent Authority.

And whereas, the Inquiry Officer has forwarded a copy of the Society's letter dated 19.09.2025, submitted by the Hon'ble Vice-President, requesting closure of the inquiry on the grounds that the complainant Sh. P.K. Jain has ceased to be a member of the Society since 2022, the then office-bearers including Sh. Rakesh Kumar Sharma, against whom allegations were made, have also ceased to be members since 2022, and that the road relaying work has already been completed and payments have been collected from the members.

And whereas, it has also been submitted that continuation of the inquiry would be infructuous and would result in avoidable financial burden on the Society due to payment of fee to the Inquiry Officer.

Now, therefore, after careful examination of the records available on file and with the approval of the Competent Authority, the inquiry initiated under Section 62 of the DCS Act, 2003 against Milan Vihar CGHS Ltd. is hereby ordered to be closed.

This issues with the prior approval of the Competent Authority.
