**ORDER**

Whereas, the Luxmi Cooperative Group Housing Society Ltd, Plot No-06, Sector-13, Rohini, Delhi-110085 is registered vide Registration No.386/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, 47 members residing in the society vide letter dated 16.12.2025, requested to appoint election officer as the member of society voted in favour of no confidence motion against the current Managing Committee of society in Annual General Body Meeting dated 05.10.2025 and current MC of the society lost its mandate to run the society and became ineffective.

Whereas, Adhoc Committee was formed by the members of society present in the AGBM dated 05.10.2025 but the charge was not handed over to them by the current Managing Committee of society.

Now therefore, the undersigned hereby convey the approval of Competent Authority to appoint Sh. G.S. Aggarwal (Retd. DRCS) as Administrator-cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Luxmi CGHS Ltd., Plot No-06, Sector-13, Rohini, Delhi-110085, to look after the day to day affairs of society with immediate effect, for a period of 90 days and to conduct elections for constituting a new Managing Committee of the society.

He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.

This issues with the prior approval of the Registrar of Cooperative Societies.
