INSTRUCTIONAL ORDER

Subject: -Reduction in rates of levying of Late Payment Surcharge (LPSC) from 5% to 2%.

Delhi Water & Sewer (Tariff and Metering) (Amendment) Regulations, 2012

(No. 01 of 2025)

F. No. UD-K01/6/2025/297565/1413.—In exercise of the powers conferred by Section 109 of the Delhi Water Board Act, 1998, the Board hereby makes partial amendment in Regulation No. 21(c) of the Delhi Water and Sewer (Tariff and Metering) Regulations, 2012 and further amends the rate of Late Payment Surcharge on the outstanding water/sewer bill, as mentioned in Regulation no. 21(c), is reduced and amended as 2% in place of 5% with immediate effect.
