
Sub.: Extension of License Period for sale of Liquor under L-1/L-1F and L-2 (Draught Beer) License up to 30.06.2025.

In accordance with the provision of Rules 34 of Delhi Excise Rules, 2010, the Competent Authority has approved the extension of validity of existing L-1/L-1F/L-2 Licensees for the sale of liquor brands registered as per approved terms and conditions for 2024-25 at their existing price up to 30.06.2025.

The L-1/L-1F/L-2 Licensees who are willing to avail of this extension period of 03 months from 01.04.2025 to 30.06.2025 to make sales of their registered brands at existing price, are required to deposit 03 months' fee i.e. License fee, Brands fee, Label Registration fee, BWH fee and any/all other fees as applicable to L-1/L-1F/L-2 Licenses on pro-rata basis for a period of 03 months in advance.

However, any person holding such non-renewable license shall not be under any obligation to accept such offer to extend his license.

Further, for new license/brand registration the applicant has to pay entire fees of the year 2024-25 and fees of 03 months on pro-rata basis.




