ORDER

Whereas, Delhi State Cooperative Union Limited, 46-Brij Mohan Marg, Darya Ganj, New Delhi-110002 (hereinafter referred to as "the Society") is a cooperative society registered with this Department under the provisions of the Delhi Cooperative Societies Act, 2003 (hereinafter referred to as "the Act") and the rules framed thereunder;

And whereas, vide this Department's Order No. F.47/AR/BKG/RCS/262/2025/2890 dated 14.01.2026, Shri Ram Naresh, Custom Superintendent, was appointed as Returning Officer of the Society for the purpose of conducting elections to the Managing Committee under Section 35(1) of the Act

And whereas, Shri Ram Naresh has since expressed his unwillingness and has refused to perform the duties of Returning Officer, thereby rendering it necessary to appoint another eligible officer for completion of the election process of the Society;

And whereas, it is imperative in public interest and in the interest of the Society that the election process is conducted and completed within the prescribed time frame, in accordance with law and the directions of the Registrar Cooperative Societies;

Now, therefore, in exercise of the powers conferred under Section 35(1) of the Delhi Cooperative Societies Act, 2003, and with the prior approval of the Competent Authority, the undersigned hereby appoints **Shri J. K. Sharma, IPS (Retd.)**, as **Returning Officer** of Delhi State Cooperative Union Limited for the purpose of conducting elections to the Managing Committee of the Society, in supersession of the earlier appointment of Shri Ram Naresh.

Shri J. K. Sharma, IPS (Retd.), shall take all necessary steps to conduct and complete the entire election process **within a period of ninety (90) days from the date of assumption of charge**, strictly in compliance with the provisions of the Delhi Cooperative Societies Act, 2003, the Delhi Cooperative Societies Rules, 2007, and the election guidelines prescribed under Rule 53 read with Schedule-II of the said Rules.

The remuneration payable to the Returning Officer shall be ₹10,000/- (Rupees Ten Thousand only), to be paid from the funds of the Society. All expenses incidental to the conduct of elections shall be borne by the Society.

The elections to the Managing Committee of the Society shall be conducted in a free, fair, transparent, and impartial manner, without any interference from any individual or authority, except as permissible under law.

The General Secretary of the Society shall extend full cooperation and shall provide all requisite records, documents, infrastructure, and logistical support to the Returning Officer to ensure smooth and timely conduct of elections.

This order issues with the prior approval of the Competent Authority.
