This order shall dispose of the proceedings initiated vide Show Cause Notice dated 17.03.2025 issued under sections 37 of DCS Act 2003.

It is noted from the record that despite issuance of repeated notices and opportunities of hearing, the Managing Committee of Prakash T/C Society has failed to file its reply to the Show Cause Notice dated 17.03.2025 and has not appeared before the RCS on any of the dates of hearing. Such conduct clearly indicates that the Society is neither interested in pursuing the matter nor inclined to comply with the lawful directions of the RCS

Accordingly, the present matter is decided ex-parte and the existing Managing Committee of Prakash T/C Society is hereby superseded. Sh. Amresh Chandra Chaudhary (AAO) is appointed as Administrator of the Society with immediate effect, who shall take charge forthwith and perform all functions of the Managing Committee in accordance with the provisions of the DCS Act and Rules until further orders. The Administrator shall submit a progress report to the RCS every 15 days regarding the functioning and status of the Society. an amount of 10,000 Rs. will be paid as remuneration from the fund of the society.
