Instructional Order

In furtherance of office order No. 139 dated 18-08-2025 and office order No. 156 dated 17-09-2025 issued by the office of Director (A&P) regarding nomenclature/ restructuring of Maintenance Circles/Divisions of Civil Wing as well as E&M Wing and their operationalization, it has been decided that the functions, roles, and responsibilities of the Division Offices shall henceforth be exercised in accordance with the new nomenclature as detailed in Annexure-I.

2. Accordingly, all Division Offices shall discharge their functions strictly as per the revised nomenclature and corresponding functions like allocation, expenditure, entries in accounting software-FMS, Banking transactions with immediate effect. Any reference to the earlier nomenclature in official correspondence, records, files, reports, and communications shall be deemed to have been substituted by the revised nomenclature. An annexure as referred above, has been attached herewith having details of the old nomenclature which has been replaced by new nomenclature alongwith Assembly Constituencies (ACs) under the jurisdiction of the division, to facilitate the divisions regarding their functions accordingly.

3. Further, All EEs/DDOs/AAOs are hereby directed to ensure that all records including Accounts books and functionalities of Accounting Software in the division is being maintained according to the new nomenclature, however, difficulties, if any, in implementation of the above may be brought to the notice of the Dy. Director (F&A)-II for consideration.
