Whereas, Sh. G.S Aggarwal, Retd. DRCS was appointed as Returning officer under Section 35(1) of DCS Act, 2003 vide this office order dated 28.02.2025 for 90 days. Further, the tenure of present Management Committee has expired on 02.04.2025 as the last election of Management Committee of society was held on 03.04.2022 because the Sh. G.S Aggarwal, Retd. DRCS was appointed as Administrator cum-R.O in Low Income Govt. Servants CHBS Ltd vide this office order dated 09.04.2025.

Now, the tenure of Administrator has expired on 08.07.2025 and Administrator vide letter dated 07.07.2025 has requested to extend his tenure for a period of 90 days.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to regularize the period from 09.07.2025 to till dated and extend the tenure of Sh. G.S. Aggarwal, Retd. DRCS Administrator-cum R.O u/s 35(5) of DCS Act 2003 in Low Income Govt.
