ORDER

Whereas, DIN CGHS Ltd. Plot No.7, Sector-4, Dwarka, New Delhi-110078 is registered with this Department vide Regn. No.852 (GH).

Whereas, the Registrar Co-operative Societies had appointed Sh. Rajender Babu Shukla, Retd. Section Officer (Grade-I, DASS), as Administrator-cum-RO, U/s 35(5) of the DCS Act, 2003 in the said society vide this office order No.F.47/RCS/H-SEC-II/GH/852/431-434 dated 12.09.2025 in DIN CGHS Ltd.
