**ORDER**

Whereas, Srinivaspuri, Mitra Mandal CGHS Ltd., Mitra Vihar, opposite D-Block, Saraswati Vihar, Pitampura, Delhi-110034, is registered with the department vide registration No.914/GH under the provision of DCS Act and Rules.

And whereas, a letter dated 11.11.2025 has been received from the Administrator of the society requesting for extension of tenure as Administrator as he could not conduct elections in the society due to the reason that some members of the society filed objections alleging that certain members whose flats were booked by MCD on the ground of unauthorized constructions among other allegations, should be debarred from participating in the elections and thus was forced to postpone the schedule of elections.

And whereas, the tenure of the Administrator of the society for one year from the initial appointment as Administrator (i.e. w.e.f. 09.10.2024) has already elapsed and he has failed to conduct elections in the society.

Now, therefore, the Registrar, Cooperative Societies/Competent is pleased to appoint Sh. Pawan Chopra, DANICS, GNCTD, as Administrator in Srinivaspuri, Mitra Mandal CGHS Ltd. Mitra Vihar, opposite D-Block, Saraswati Vihar, Pitampura, Delhi-110034 under section 35(5) of Delhi Co-Operative Societies Act, 2003 to manage the day to day affairs of the society and to re-establish the democratic setup in the society within a period of 90 days by way of conducting the election of the Managing Committee of the society as per the Rule 53 & Schedule II of the DCS Rules, 2007.

Further, the Administrator shall draw a sum of Rs. 10,000/- (Rs. Ten thousand only) as honorarium along with conveyance charges and other election expenses from the funds of the society.
