**Subject: Compliance of Hon'ble CAT interim Order dated 27.01.2026 in OA No. 83/2026**

Whereas, this office had issued Order No. 172 dated 03.12.2025 with the Approval of the Competent Authority, for Stopping the payment of benefits to Group-'B' officers/employees of Ministerial Cadre (i.e. ASO/SO/AO/ZRO) who were granted 3<sup>rd</sup> MACP in PB-2 with Grade Pay of Rs. 4600/- and Rs. 4800/- after availing Non-Functional Selection Grade (NFSG) in PB-2 with Grade Pay of Rs. 4200/-, and for re-fixation of pay/pension and consequent recovery, wherever applicable.

Whereas, 21 retired employees/pensioners, affected by the aforesaid order, have filed OA No. 83/2026 before the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi, seeking relief against re-fixation of pension and consequent recovery..

And whereas, the Hon'ble CAT, Principal Bench, New Delhi, vide its Order Dated 27.01.2026, has directed the respondent i.e. Delhi Jal Board that "*By way of ad-interim measure, respondents are directed not to take any coercive steps against the applicants till the next date of hearing*", and the matter has been notified for further hearing on 11.03.2026.

Now, therefore, in compliance of the aforesaid order of the Hon'ble CAT, it is hereby ordered that:

1. All Drawing & Disbursing Officers (DDOs) concerned shall maintain *status quo* in respect of the applicants of OA No. 83/2026 titled as "*Yogamber Singh Bhandari & Ors. Vs Delhi Jal Board*".
2. No recovery of any excess payment shall be made from the pension of all the retired employees/pensioners who are affected from Order No. 172 dated 03.12.2025.
3. The above directions shall remain in force till further orders/directions from the Hon'ble CAT or the Competent Authority.

This issues with the approval of the Competent Authority.
