ORDER

Whereas Canara Cooperative Group Housing Society Ltd., Plot No.16, Sector-13, Rohini Delhi-110085, is registered with this department under the provision of DCS Act/Rules & registered Bye-Laws of the society.

Whereas vide Order No. F.47ARH/747-GH/Sec-II/RCS/2022/435 dated 15.09.2025, Sh. Harvinder was appointed as Inspection Officer under Section 61(1) of the DCS Act, 2003 to conduct inspection of the records of Canara CGHS Ltd. To verify the allegation made in the complaint dated 14.12.2021.

And whereas vide this office order dated 18.12.2025, the tenure of the Inspection Officer was extended up to 30.01.2026 on his request, with directions to complete the inspection and submit the inspection report by the said date.

And whereas the Inspection Officer, vide letter dated 27.01.2026, has reported non-submission of legible documents by the respondent Society, due to which the inspection could not be concluded within the stipulated period, and has sought extension of time up to 20.02.2026.

And whereas the Inspection Officer, vide letter dated 18.02.2026, has further requested extension of time up to 27.02.2026, submitting that the Society has since provided voluminous documents and legible copies, which are presently under detailed examination;

Now, the Registrar of Cooperative Societies, after due consideration, has acceded to the request of Sh. Harvinder Kumar for extension of his tenure as Inspection Officer up to 27.02.2026 and has approved the extension of his tenure as Inspection Officer in respect of Canara CGHS Ltd. from 31.01.2026 to 27.02.2026 for the purpose of conducting inspection of the records of Canara CGHS Ltd. under Section 61 of the DCS Act, 2003, to inquire into the allegations made in the complaint dated 14.12.2021. The Inspection Officer shall complete the inspection and submit his report by 27.02.2026.
