ORDER

Whereas, the New Inderprastha CHBS Ltd., 91-Inder Enclave, Rohtak Road, New Delhi-110087 is registered with this Department vide Regn. No. 1462 (HB) under the provisions of DCS Act and Rules.

And whereas, the Ld. Financial Commissioner passed an Order dated 19.12.2025 in Case No. 62/2023, titled Sh. Alok Jain Vs RCS & Ors vide which it is stated that :-

"The matter merits a proper examination of all records since 1968. Hence, to assist the court of the Financial Commissioner, the RCS is directed to appoint a fact finding committee under an experienced retired Assistant Registrar, which shall examine all records and submit a report with recommendation (in a sealed envelope) after hearing all the parties within a period of three weeks".

Now, therefore, in compliance of Order dated 19.12.2025 passed by the Ld. Financial Commissioner, the undersigned is directed to convey the approval of Worthy Registrar Co-operative Societies, GNCT of Delhi, that **Sh. Soran Singh, Retd., Deputy Director, Deptt. of Social Welfare, GNCTD** has been appointed as a Nodal Officer under which **Sh. Mukesh Chand, Section Officer, and Sh. Vishesh, Sr. Asstt.**, shall work as a fact finding committee, which shall examine all records since 1968 pertaining to this case and submit a report with recommendation (in a sealed envelope) to the Ld. Financial Commissioner after hearing all the parties within a period of three weeks from the receipt of this Order. An honorarium of Rs. 10,000/- (Rupees Ten Thousand Only) shall be paid to Sh. Soran Singh and an honorarium of Rs. 7,500/- (Rupees Seven Thousand Five Hundred Only) shall be paid to each committee member equally by the petitioner/Sh. Alok Jain and R-3/Sh. R.K. Aggarwal.
