ORDER

Whereas, the Kasturba Cooperative Group Housing Society Ltd, Kasturba Apartment, Pitampura, Delhi-34 is registered vide Registration No. 150/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, President of the society has informed that Election of the society was held on 15.09.2024 following due process. However, no nominations for elections were received and despite the best efforts of the Management Committee, none of the society members came forward to file the nomination to constitute new Management Committee.

Whereas, the tenure of the present Managing Committee was expired on 19.09.2021 and Management Committee of the society lost its mandate to functioning the society and requested to appoint administrator in the society.

Whereas, Sh. Rajender Babu Shukla, Retd. Section Officer was appointed as an Administrator under section 35(5) of DCS Act 2003 in the society for 90 days vide this office order no.107679472/RCS/S-IV/2024/735 dated 11/10/2024 to get the election conducted at the earliest.

And whereas, the administrator informed that the outgoing MC of the said society handed over the charge to him on 30/11/2024 and due to delay in handing over the charge he could not conducted the election process so far.

And whereas, the administrator Sh. Rajender Babu Shukla, Retd. Section Officer has requested this office to extend his tenure further.

Now therefore, the undersigned hereby convey the approval of the Competent Authority to regularize the past period i.e 11.01.2025 to 02.03.2025 and extend the tenure of Sh. Rajender Babu Shukla, Retd. Section Officer as Administrator u/s 35(5) of DCS Act 2003 for 90 days with the direction to conduct elections for the constitution of the new Managing Committee of the society. He will also submit a regular monthly status report related to the functioning of the society to this office.

Administrator will be paid Rs. 10,000 /- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.

This issues with the prior approval of the Competent Authority.
