

ORDER

The Competent Authority has granted the approval for extending the Excise Duty Based Regime of Licensing Year 2024-2025 for further 03 months i.e. up to 30.06.2025 and period of all existing L-1/L-1F/L-2 licenses are extended up to 30.06.2025 on payment of requisite license fee on a pro rata basis on the same terms and conditions as that of 2024-2025. In addition, all licenses which are renewable every year are also allowed to renew for 03 months i.e. up to 30.06.2025 on a pro rata basis on the same terms & conditions as that of Excise Year 2024-2025.

Necessary circulars may be issued in this regard by the concerned branches dealing with all the licenses and permits granted/renewed under Delhi Excise Rules, 2010.
