



The officials concerned may be allowed to exercise their options, if any, under FR22 within one month of the issuance of the order for granting the financial up gradation under the Modified Assured Career Progression Scheme. However, the grant of higher pay scale is subject to the condition that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The Head of office concerned is requested to ensure, before granting the Financial up gradation under the Modified Assured Career Progression Scheme to Officer/Officials i.e. Leading Fireman, Fire Operator and MTS that 10 years regular service does not include the period of service rendered in State Government /Statutory Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No.10 of DoPT OM No.35034/3/2008-Estt(D) Dated 19.05.2009).
