**Sub: Preparatory exercise for Special Intensive Revision-regarding**

Sr.

1. I am directed to refer to the ECI's letter no. 23/2026-ERS (Vol II) dated 19<sup>th</sup> February 2026 (copy enclosed) on the subject cited above wherein it has been informed that Special Intensive Revision (SIR) is expected to start from April 2026 and accordingly it has been requested to complete preparatory work related to SIR, at the earliest.

2. Presently, mapping of electors of electoral roll-2025 is being done vis-à-vis electors of year 2002, which is a crucial exercise before start of actual SIR and has to be completed in a time bound manner. The Booth Level Officers (BLOs) have to visit house to house on daily basis to obtain electoral details of year 2002 from each elector of their allotted part for mapping in the electoral roll of year 2025. As per instructions of the ECI, BLOs have to perform their duties after their regular office hours and on Sundays/Holidays.

3. It has been learnt that the Booth Level Officers (BLOs) are not visiting house to house after office/school hours resulting in very low percentage of mapping i.e. approx. 30% only in NCT of Delhi. On enquiry, it has been found that BLOs are assigned additional work by their parent department to be performed after office hours.

4. In view of the above, I am directed to request you to kindly direct all the officials under your jurisdiction who have been deployed as BLOs to perform their BLO duties after office/school hours on daily basis in order to complete their task in a time bound manner. Further, it is also requested not to allot any other additional work to the BLOs after office hours so that election related works does not suffer.

5. This issues with the approval of Chief Electoral Officer, Delhi.

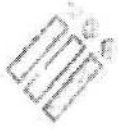
