2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

Qualification:-

1. (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.

(2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 year's experience in concerned specialty may be considered on adhoc basis till the regular candidate joins.

- 2. <u>Age</u> :- Below 45 years, **On Date of Interview**, shall be for General candidates. 5 years relaxation for SC/ST. Person with disabilities shall be given relaxation as per Govt. of India rules.
