In exercise of the powers conferred under Section 357 A of the Code of Criminal Procedure, 1973 and in partial modification of this Government's notification No. F.11/35/2010/HP-IJ/2677-2693 dated 27<sup>th</sup> June, 2019, the Lieutenant Governor of National Capital Territory of Delhi hereby makes the amendment in the 'Delhi Victims Compensation Scheme, 2018', as under:

## Amendments :

In Clause 2 (k), the definition of "Victim" shall be as under:-

"Victim" includes a person who has suffered loss or injury as a result of the offence including the offence of mob violence and mob lynching and in the case of his/her death, the expression ' victim' shall mean to include his/her guardian or legal heir;

provided that for the purpose of compensation, the victim of mob violence/mob lynching shall be the one who is treated as victim of mob violence/mob lynching by the court or investigating agency.

In Rule 13, following is inserted:-

Provided further that in case of mob violence/mob lytiching, the interim relief to the victim, including the interian compensation shall be provided within 30 days from the date of offence and the limit of 4s. 50,000/- for interim compensation shall not be applicable to the cases of such victims but the upper limits of compensation provided under the schedule to the scheme shall continue to apply.

The notification shall come into force on the date of publication of this notification in the Official Gazette.
